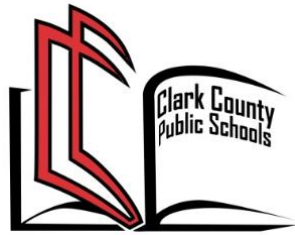

Clark County Public Schools will be participating in the National School Lunch Program and the School Breakfast Program. As part of this program, **Clark County Preschool, Baker Intermediate School, Conkwright Elementary School, Justice Elementary School, Shearer Elementary School, Strode Station Elementary School, Campbell Jr. High School, Phoenix Academy, and George Rogers Clark High School**, will offer healthy meals every school day at NO COST to the students due to the implementation of the Community Eligibility Provision for school year **2021-2022**. Students will be able to participate in these meal programs without having to pay a fee or submit a household application.
